## F-22 Raptor, Air Dominance for the 21st Century

Chapter Vice President John Reitz has announced that on February 9, 2007, Mike Merritt, Director F-22 Improvements and Derivatives at Lockheed Martin Aeronautics Company in Marietta, Georgia, will be our guest speaker. Mike will be presenting a program on the F-22 Raptor USAF fighter plane.

It was only 20 months ago that the first Raptor was delivered to Langley AFB. It will soon be deployed at the Kadena Air Base, Japan.

No fighter plane in the world comes close to matching the F-22. By every measure, the Raptor represents an extraordinary breakthrough in maneuverability, stealth, sensor fusion and a wealth of parameters that define a new era in fighter capability.

The F-22 is capable of flying and fighting against the most advanced integrated radar networks and dense surface-to-air missile environments in the world, now and in the future. The F-22 will retain the competitive edge through innovations and technologies no one can match.

In early 2001, the U.S. Air Force introduced a concept called Global Strike Task Force in which the Raptor is the enabler for all other forces. The success of any major air-land operation today and in the future

depends primarily on the United States' preeminent ability to detect and destroy enemy fighters as well as attack high-value ground targets with precision weapons. With the F-22, the era of U.S. air dominance against all ground and air-based threats has begun.



Prior to joining Lockheed Martin, Mike spent 20 years in the United States Air Force. He has over 3,000 hours of pilot time and is an Outstanding Graduate of the USAF Fighter Weapons School. His fighter experience includes the F-4, A-7, A-10, and F-117 aircraft. He was one of the first operational pilots to fly the Stealth Fighter. Mike retired from the Air Force as a Lieutenant Colonel in 1993 and joined Lockheed Martin Advanced Development Programs (the Skunk Works) in Palmdale,

CA as a Project Manager for the F-117. In 1998 he transferred to the F-22 program in Marietta, GA and became the Improvements and Derivatives Director in 2004. In his spare time, Mike is a Certified Flight Instructor and provides training for tail-wheel endorsements and aerobatics in his Decathlon.

### Airport Visits Hosted by Chapter 690

Airport visits hosted during 2006 included thirty-six (36) groups with five hundred ninety-seven (597) students and three hundred and four (304) adults.

### Scott Haslup Receives Air Force Pilot Wings

2d Lt. Scott Haslup, son of EAA 690 and IAC-3 member Steve Haslup and Sara Haslup, graduated from Air Force Undergraduate Pilot Training (UPT) and received his Air Force Pilot Wings on October 20, 2006.



Scott completed his entire training at Laughlin AFB in Del Rio, Texas. In the first half of his pilot training he flew the second generation T-6A Texan. This airplane has a single turbo-prop engine that delivers 1,100 horsepower, climbs at 3,100 feet per minute, and sports modern avionics in a glass cockpit.

After completing the T-6A program, Scott qualified for the fighter/bomber track and flew the T-38 Talon for the second half of UPT. The T-38 has two GE jet engines, a max speed of 1.3 Mach, and can climb to 30,000 ft. in one minute. Scott will serve as an Instructor Pilot at Laughlin AFB for up to three years. He is a 2005 graduate of the USAF Academy.

Scott's father, Steve, a long-time member of EAA 690, has held several leadership positions in IAC Chapter 3. He flies his LZU-based aerobatic Atlantis II for fun and in aerobatic competitions around the Southeast.

## Georgia Airports Funding Bill

Date: Wed, 24 Jan 2007  
Subject: House Resolution 48

House Resolution 48 is a proposal to change the Georgia Constitution. Currently taxes on aviation fuels are put into the state's general fund and the legislature appropriates approximately \$5 million annually to the Georgia Aviation Programs Office. (Complete text of HR 48 is available at <[http://www.legis.ga.gov/legis/2007\\_08/search/hr48.htm](http://www.legis.ga.gov/legis/2007_08/search/hr48.htm)>). The \$5 million that is presently being appropriated to airport projects each year falls well short of what is needed to meet the present maintenance needs, much less capital improvements and expansion projects.

Our border states are funding their airports at a much higher level. This will eventually result in Georgia losing business opportunities to these states. To remain competitive, Georgia must provide an adequate and well-maintained system of airports capable of servicing today's general aviation fleet. HR 48 is important to the economic prosperity of Georgia as well as Georgia Airports. Airports can and do have a tremendous economic impact on the

communities they serve. Aviation activity in our state generates in excess of \$100 million in state and local tax revenue and billions more in direct/indirect economic benefits to the local economies linked to each of Georgia's 106 public use airports.

We have significant support in both houses of the legislature however we need your involvement. I encourage everyone to contact (e-mail is very effective) your representatives and senators and voice your support. You can find your representative's e-mail address at <http://www.legis.state.ga.us>

## Honoring the Tuskegee Airmen

The Tuskegee Airmen were dedicated, determined young men who enlisted to become America's first black military airmen, at a time when there were many people who thought that black men lacked intelligence, skill, courage and patriotism. Most were college graduates or undergraduates. Others demonstrated their academic qualifications through comprehensive entrance examinations. No standards were lowered for the pilots or any of the others who trained in operations, meteorology, intelligence, engineering, medicine or any of the other officer fields. Enlisted members were trained to be aircraft and engine mechanics, armament specialists, radio repairmen, parachute riggers, control tower operators, and all of the other skills necessary to fully function as an Army Air Corps flying squadron or ground support unit.

On Saturday, February 3, 2007, at 10:30 a.m., our very special guest, Mr. LeRoy (Roy) Eley, Sr., Tuskegee Class 46-D will discuss some of the truths and facts regarding the history of the TUSKEGEE ARMY FLIGHT TRAINING PROGRAM. Roy will also discuss some of the little known history of the group and what happened to some of these people after the war ended.

Eley volunteered for the USAF at the age of 17. He earned his Private Pilot License in 1946, followed by his Commercial, Flight Instructors (single and multi-engine) and Instrument Instructors rating. He also holds an Airline Transport Pilots (ATP) license and is jet rated. Prior to retiring, Roy served as an FAA Flight Inspector in the Georgia Flight Standards District Office. He remains active as a charter member of the Negro Airmen, International, Black Pilots of America and the Atlanta Chapter of the Tuskegee Airmen.

## Skydiving and Parachute Operations

Chuck was born & raised in Kentucky "a long time ago." His Grandfather started him fishing at two, his Father started him hunting at eight, and he still fishes & hunts when possible.

He earned his B.S. in Chemical Engineering through Cooperative Education Program at the University Of Cincinnati. He did Masters-Bus Ad Marketing Work at Fairleigh Dickison University, which was curtailed due to business travel.

Chuck will talk to us about Skydiving & Parachute Operations. He had his first Skydive on 07-DEC-1975. He Currently has 715 Skydives and 665 Minutes, 42 Seconds Freefall, Skydiving License D-8672 and inactive Accelerated. He has his Freefall Jumpmaster Rating and holds a Private SEL License.
