While I was flying last month checking out new prop and Garmin GPS radio I noticed the right hand fuel tank gauge go from 3/4 full to E in a blink of an eye. Switched tanks thinking I had a major fuel leak and headed back to FPR. Landed and checked fuel level visually to find the tank 3/4 full. Checked wiring and found no apparent problem. Pulled all access panels to visually inspect fuel level sending unit connection, nothing unusual. Drained right fuel tank (14 gals) and removed fuel sending unit with no float attached. Had to open tank to retrieve the d—- float. Lots of work, small working area. I'm now back in the air!!!
