I'm reprinting this info for anyone who may have missed it last month.

Important information to all lease holders and renters of hangers, tie downs, containers, and parking spaces.

It was brought to our attention that we are responsible for collecting and paying taxes to the state of Florida for rental and leasing of real estate. Even though we are a 501 C3 non profit entity we are still liable for this tax issue. The BOD has researched this with tax lawyers and CPA's so we are taking the following steps to correct this issue.

The State of Florida has a Voluntary Disclosure Program that we can comply with and not be heavily fined or penalized because of these tax laws violations.

The penalty for using this Voluntary Disclosure is 3 years back taxes that are being paid and we are registering with the state to charge the appropriate tax and submitting to the state.

The BOD decided to take care of this matter to prevent any possible future interactions by the state as far as being tax delinquent.


